Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

Promotion Overview:

Kohl's Holiday Quest Promotion (the "Promotion") includes an ("Instant Win Game") and a ("Sweepstakes").

Eligibility:

The Promotion is open only to legal residents of the 50 United States and the District of Columbia who are at least 18 years old at the time of entry. To receive a prize valued at \$2,000 or more, entrant must be able to submit a valid IRS Form W-9. Employees of Kohl's, Inc. ("Sponsor"), Merkle Inc. ("Administrator"), and their parent and affiliate companies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible.

Agreement to Official Rules; Entrants Will Be Disqualified for Violations:

Participation constitutes entrant's full and unconditional agreement to these official rules ("Official Rules"). The Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited. Sponsor's and Administrator's decisions are final and binding in all matters related to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein. In the event there is a discrepancy or inconsistency between any other statements contained in any Promotion-related materials (including printed versions of these Official Rules) and the Official Rules as posted on the Promotion Site (defined below in the "How to Enter" Section), the Official Rules as posted on the Promotion Site shall prevail, govern and control. Timing:

The Promotion begins on November 7, 2025 at 12:00 a.m. Eastern Time ("ET") and ends on December 25, 2025 at 11:59 p.m. ET (the "Promotion Period").

For the Instant Win Game, there are 3 phases, as outlined below:

Administrator's servers are the official time-keeping devices for the Promotion.

How to Enter:

During the Promotion Period, visit www.kohlsholidayquest.com ("Promotion Site") and follow the links and instructions to accurately complete and submit the registration form, including your first and last name (initials are not sufficient), email address, and home address (P.O. Boxes are not permitted). You will receive 1 entry into the Sweepstakes and 1 Instant Win Game play per day. Once on the Instant Win Game page, follow the links and instructions and the results of the Instant Win Game will be displayed. If you play the Instant Win Game and you are not a potential winner of an Instant Win Game prize, you will, however, receive 1 additional Sweepstakes entry. Potential winners of the Instant Win Game will receive an email notification with prize claim instructions. Only potential winners who timely complete prize claim requirements and/or are verified as eligible, subject to household prize limits, will be awarded a prize. Administrator is responsible for the functionality of the Instant Win Game. Entry Limit: You may receive 1 Sweepstakes entry and 1 Instant Win Game play per day during the Promotion Period for registering or logging into the Promotion Site; you may receive 1 additional Sweepstakes entry per day during the Promotion Period if you lose the Instant Win Game, as outlined above.

Method 1 - Purchase Method of Entry and/or Mail-in Method of Entry:

• Purchase Method: During the Promotion Period, visit a Kohl's store location in the United States (including the District of Columbia) or https://www.kohls.com/ and make a purchase ("Qualifying Purchase") and keep your receipt. Receipts cannot be given away, bartered, auctioned, sold, or traded and all such receipts may be void. Participation in the Program by individuals who take such actions may be terminated at Sponsor's discretion. Your receipt will include a barcode. During the Promotion Period, visit the Promotion Site and follow the links and instructions to register or log in (as outlined above) and then click on the "Scan Barcode on Receipt" button and use a mobile device or desktop computer with a camera and scan the barcode on your receipt. You can only scan 1 Qualifying Purchase barcode per day during the Promotion Period. Each Qualifying Purchase barcode can only be scanned 1 time during the Promotion Period.

Once your Qualifying Purchase has been validated, you will receive 1 "Punch" on a virtual "Punch Card." Once you make 3 Qualifying Purchases/earn 3 Punches on your Punch Card, you will receive 20 additional entries into the Sweepstakes. Once you make 6 Qualifying Purchases/earn 6 Punches on your Punch Card, you will receive 50 additional entries into the Sweepstakes. Once you make 9 Qualifying Purchases/earn 9 Punches on your Punch Card, you will receive 100 additional entries into the Sweepstakes.

Mail-in Method: To enter without making a Qualifying Purchase, print your name, address, phone number, email address, and date of birth on a piece of paper and mail it in an envelope with proper postage to "Kohl's Holiday Quest Promotion," c/o Merkle Inc., P.O. Box 5025, Department 867796, Kalamazoo, MI 49003-5025. You must also list out the number of Punches for which you are entering on the outside of the envelope, (either "3 Punches", "6 Punches", or "9 Punches"). If you write "3 Punches" on the outside of your envelope, you will receive 20 additional entries into the Sweepstakes. If you write "6 Punches" on the outside of your envelope, you will receive 50 additional entries into the Sweepstakes. If you write "9 Punches" on the outside of your envelope, you will receive 100 additional entries into the Sweepstakes. Limit: 1 request per envelope. You may only submit 1 mail-in request for 3 Punches, 1 mail-in request for 6 Punches, and 1 mail-in request for 9 Punches. If you do not indicate the number of Punches on the outside of the envelope, your entry will be voided, and you will not receive any entries into the Sweepstakes. All mail-in entries must be sent/postmarked by December 26, 2025 and received by January 5, 2026. All entries become the exclusive property of Sponsor and none will be acknowledged or returned. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected or postage-due entries, which will be disqualified.

Limit: You may receive up to 170 additional Sweepstakes entries during the Promotion Period by any combination of the entry methods listed above (making a Qualifying Purchase and/or sending in a mail-in entry).

Method 2 – Kohl's App: Visit the Promotion Site and follow the links and instructions to click on the Kohl's App button to receive 1 additional entry into the Sweepstakes. **Limit:** You may receive 1 additional Sweepstakes entry during the Promotion Period via this method.

Entry Limits:

Multiple entrants are not permitted to share the same email address. In the event of a dispute as to the identity of an entrant, Sponsor and Administrator will rely on the information submitted by the entrant to register for this Promotion. If any additional information provided by entrant is inconsistent with the information provided at registration for this Promotion, Sponsor and/or Administrator may disqualify such entrant and such disqualification may result in the forfeiture of any prizes won. Sponsor, in its discretion, may require additional documentation from entrant to show proof of entrant's identity.

Operation of Sweepstakes and Instant Win Game:

Administrator is an independent organization whose decisions as to the administration and operation, including the selection of potential winners, are final and binding in all matters related to the Promotion.

Sweepstakes:

Administrator will randomly select the potential Sweepstakes winner from all eligible entries received during the Promotion Period, on or around January 13, 2026 and will notify potential winner by email. The odds of winning a prize depend on the total number of eligible entries received during the Promotion Period.

Instant Win Game:

There will be 14,500 random, computer-generated winning times seeded, one for each Instant Win prize offered. For the Phase 1 Instant Win Game Prize, there will be 250 random, computer-generated winning times seeded per day during Phase 1. For the Phase 2 Instant Win Game Prize, there will be 500 random, computer-generated winning times seeded per day during Phase 2. For the Phase 3 Instant Win Game Prize, there will be 250 random, computer-generated winning times seeded per day during Phase 3.

If you are the first player to play the Instant Win Game at or after one of the randomly-seeded times, you will be a potential instant winner of the prize indicated, subject to verification of potential winner's eligibility and the household prize limitations.  Wisconsin without giving effect to any choice of law or conflict of law rules (whether of the State

If the application of any provision of these Official Rules to any particular facts or circumstances shall for any reason be held to be invalid, illegal or unenforceable by a court, arbitration panel or other tribunal of competent jurisdiction, then:

- The validity, legality and enforceability of such provision as applied to any other particular facts or circumstances and the other provisions of these Official Rules shall not in any way be affected or impaired thereby; and
- Such provision shall be enforced to the maximum extent possible.

In addition, if any provision contained in these Official Rules shall for any reason be held to be excessively broad as to duration, geographical scope, activity or subject, it shall be construed by limiting and reducing it so as to be enforceable to the extent compatible with applicable law.
